THE SUMMER SCHOOL OF ROCK PROGRAM PROVIDES 3 HOURS OF DAILY MUSICAL INSTRUCTION, YOGA, MEDITATION, AND ART TO CAMPERS WHO RANGE IN AGE FROM 8 TO 12 YEARS OLD. 27 CAMPERS ATTENDED THE PROGRAM AND \$4,451 OF CAMP TUITION / SPONSORSHIPS WAS RAISED TO FUND IN-SCHOOL ARTS AND MUSIC ENRICHMENT PROGRAMS. THIS PROGRAM SAW A 42% INCREASE IN THE NUMBER OF CAMPERS FROM THE PRIOR YEAR AND A 322% INCREASE IN FUNDS AVAILABLE TO THE SCHOOLS.
